POLL RESULTS AT ANNUAL GENERAL MEETING HELD ON 12 AUGUST 2010

The Board is pleased to announce that all proposed resolutions as set out in the Notice were duly passed at the AGM by way of poll.

Reference is made to the circular (the "Circular") of HKR International Limited (the "Company") and the notice of the annual general meeting (the "Notice") both dated 12 July 2010 and issued to the shareholders of the Company. Unless the context otherwise required, terms defined in this announcement shall have the same meanings as those defined in the Circular and the Notice.

RESULTS OF THE AGM

The board of directors of the Company (the "Board") is pleased to announce that at the annual general meeting of the Company held on 12 August 2010 (the "AGM"), all proposed resolutions as set out in the Notice were duly passed by way of poll.

As at the date of the AGM, the Company had 1,350,274,367 shares of par value of HK\$0.25 each in issue, which was the total number of shares entitling the shareholders to attend and vote for or against the resolutions at the AGM. There was no restriction on any shareholders casting votes on any of the resolutions at the AGM.

The Company's branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking. The poll results in respect of the resolutions proposed at the AGM are as follows:-
