- 3. Any member of the Company entitled to attend and vote at the Meeting is entitled to appoint another person as his proxy to attend and vote instead of him. A proxy need not be a member of the Company. A member may appoint more than one proxy to attend the same occasion.
- 4. If any proxy other than the chairman of the Meeting is preferred, please strike out "THE CHAIRMAN OF THE MEETING or" and insert the name and address of the proxy desired in the space provided.
- 5. IMPORTANT: IF YOU WISH TO VOTE FOR THE RESOLUTION, PLEASE TICK ("\superscript\*") IN THE RELEVANT BOX MARKED "FOR". IF YOU WISH TO VOTE AGAINST THE RESOLUTION, PLEASE TICK ("\superscript\*") IN THE RELEVANT BOX MARKED "AGAINST". Failure to complete either box will entitle your proxy to cast your vote or abstain at his discretion. A member present by proxy is entitled to one vote for every fully-paid share held and a member entitled to more than one vote need not cast all his votes in the same way. A tick ("\superscript\*") in the relevant box indicates that the votes attached to all the shares stated above as held by you will be cast accordingly. A number in the relevant box indicates that the votes attached to the number of shares referred to in the box will be cast accordingly.
- 6. This form of proxy must be signed by you or your attorney duly authorised in writing or, in case of a corporation, must be either under seal, or under the hand of an officer or attorney duly authorised.
- 7. Where there are joint registered holders of any shares in the Company, any one of such persons may vote at the Meeting, either personally or by proxy, in respect of such shares as if he were solely entitled thereto; but if more than one of such joint holders are present at the Meeting personally or by proxy, that one of the said persons so present whose name stands first on the register of members of the Company in respect of such shares shall alone be entitled to vote in respect thereof.
- 8. To be valid, this form of proxy, together with the power of attorney or other authority, if any, under which it is signed or a notarially certified copy of that power of attorney or other authority, shall be deposited at the Investor Centre of the Company's share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not less than 48 hours before the time appointed for holding the Meeting (i.e. at or before 11:00 a.m. on Monday, 20 August 2018) or any adjournment thereof (as the case may be).
- 9. Completion and return of the form of proxy will not preclude you from attending and voting in person at the Meeting or any adjournment thereof should you so wish. In such event, the form of proxy shall be deemed to be revoked.
- 10. REGISTRATION OF THE MEETING WILL START AT 10:15 A.M. ON WEDNESDAY, 22 AUGUST 2018. TO ENSURE THAT THE MEETING CAN START ON TIME, SHAREHOLDERS OR THEIR PROXIES ARE REQUESTED TO ARRIVE AT THE VENUE FOR REGISTRATION AT LEAST 15 MINUTES BEFORE THE MEETING STARTS.
