1. The Company's 2011 Share Option Scheme was adopted on 8 September 2011 and the listing status of the ordinary shares to be granted under the scheme was granted by the Stock Exchange on 9 September 2011.

2. 440,000 share options were lapsed on 3 February 2019 due to the expiry of exercisable period in accordance with the terms of granting of share options on 12 March 2018.

3. 45,100,000 outstanding share options comprising:-
 - i) 17,160,000 share options at the exercise price of HK\$3.845 per share with exercisable period of 28 February 2017 to 27 February 2027; and
 - ii) 27,940,000 share options at the exercise price of HK\$4.373 per share with exercisable period of 12 March 2018 to 11 March 2028.
