  - i) 17,160,000 share options at the exercise price of HK\$3.845 per share with exercisable period of 28 February 2017 to 27 February 2027; and
  - ii) 27,720,000 share options at the exercise price of HK\$4.373 per share with exercisable period of 12 March 2018 to 11 March 2028.
